# STOWELINK CHIEF PROGRAMS OFFICER MEETS WITH BAN KI MOON DURING THE AFRICA CLIMATE SUMMIT

Stowelink's Chief Program Officer got an opportunity to meet H.E. Ban Ki-moon, the 8th Secretary General of the United Nations (UN) at the Africa Climate Summit. H.E Ban Ki-moon, through the Ban Ki-moon Center for Global Citizens, has demonstrated commitments to work with global leaders and changemakers to tackle climate change and economic upheavals. He has sought to be a bridge-builder, giving voice to the world's poorest and most vulnerable people and strengthening world pandemic response initiatives. As the chief architect of the 2030 agenda for SDGs, he joined host of delegates to discuss climate change adaptation and reinforce the need for increased attention and budgetary allocation for climate change mitigation efforts.

# STOWELINK JOINS THE LAUNCH OF THE STRATEGIC PLAN TO TACKLE NON-COMMUNICABLE DISEASES

Stowelink joined the Non-communicable Diseases Alliance Kenya (NCD Alliance Kenya) to launch the 2023-2027 Strategic Plan for tackling chronic diseases in Kenya. The plan provides a roadmap toward reducing preventable morbidity, mortality, and disability due to NCDs in Kenya. Speaking during the launch, Dr. Issak Bashir, the Head of the Department of Family Health in the Ministry of Health, noted that the Strategic Plan 2023-2027 is a response to epidemiological transition from communicable diseases to non-communicable diseases being experienced in Kenya. He insisted the need for a concerted effort to address NCDs risk factors and management gaps to achieve the desired health outcomes. A member of the alliance, Stowelink pleages to support the full implemenation of the strategic plan.

# UNVEILING INSIGHTS: STOWELINK FOUNDATION EMBARKS ON DATA ANALYSIS FOR STEP UP PROJECT

In an exciting development this quarter, STOWELINK Foundation has initiated the comprehensive analysis of data accumulated over the past year from the STEP UP project in the Nairobi Githurai area. This pivotal stage marks the beginning of a rigorous process that will eventually culminate in the production of a research paper, shedding light on the profound insights into the interconnection between Non-Communicable Diseases (NCDs) and climate change.



#### Data Collection Milestone:

The STEP UP project, implemented over the course of a year, has been diligently collecting data since its inception. This data spans a diverse range of variables, reflecting the intricate relationship between NCDs and climate change among the youth in the Githurai area. Through in-person training sessions, an online course, and the innovative use of the NCDs 365 mobile application, the project aimed to empower the youth with knowledge to foster sustainable health practices and climate resilience.

#### Data Analysis Process:

The current phase involves a meticulous examination of the collected data. STOWELINK's team of researchers and data analysts are employing advanced statistical methods and data visualization techniques to draw meaningful insights from the wealth of information gathered. This rigorous analysis aims to uncover patterns, trends, and correlations that will form the basis of the forthcoming research paper.

#### Path to Publication:

As the data analysis progresses, STOWELINK Foundation is gearing up for the preparation and submission of a research paper that encapsulates the findings and outcomes of the STEP UP project. The paper will be a valuable contribution to the scientific community, providing evidence-based insights into the impact of tailored educational initiatives on youth awareness regarding the interconnectedness of NCDs and climate change.



#### Importance of the Research:

The significance of this research extends beyond the academic realm. The interplay between NCDs and climate change is a critical aspect of public health, particularly in urban environments with burgeoning youth populations. Understanding the dynamics of this relationship is crucial for implementing effective interventions and fostering sustainable health practices. The STEP UP project, and consequently, its research outcomes, not only contribute to the scientific discourse but also inform policymakers, healthcare practitioners, and communities about the shared risks and potential solutions.

# THE 21ST- NCD YOUTH CHAMPIONS 4 CLIMATE CHANGE

The 21st NCDs Youth 4 Climate is a project that aims at creating a movement of trained and empowered NCDs champions called The Twenty-Firsts who are knowledgeable on NCDs and climate change and the close interrelationship between the two topics. The Twenty-Firsts will be responsible for educating their communities on these topics thus creating a snowballing impact and as a result improving on literacy and practices aimed at leveraging co-benefit solutions and impact gained from action on NCDs and climate change.

#### DFITVFRY PLAN

Stowelink proposes to deliver on this project by following this model.

- 1. Identify and train at least 40 youths from each of the 10 institutions of higher learning that we have clubs in or are working with health and environment clubs.
- 2. Engage the trained NCD champions also identified as the Twenty Firsts in activities such as tree planting, cookstove technology lessons, to gain practical knowledge of these co-benefit actions on NCDs and climate change.
- 3. The Twenty-Firsts will then be tasked with training and educating their communities on the same knowledge and recruiting new members through the health and environmental clubs that they are members of. This will ensure the sustainability of the project beyond the funding.
- 4. The project will also leverage the NCDs 365 app and the NCDs For Public Health Online Course both by Stowelink's knowledge partner, NCDs Champions, to enhance the learning, monitoring and reporting processes of the project. The online course will enable the students to learn and have a reference point as well. The NCDs 365 app will be updated with information on NCDs and climate change to provide on-thego access to this information to the Twenty-Firsts. More than that the app will be the central platform where all updates, communication, and reporting from all the institutions will be managed. These components are key to this project as they will ensure the sustainability of the project and easy replication of the project to other locations.
- 5. The project will also have a very strong research component with Quarterly KAP (Knowledge, attitude, and practice) surveys which will be conducted to establish the impact of the project on the desired outcomes e.g behavior change and knowledge retention among many others.



Recently launched, Phase 1 of the project is a dynamic stage that involves reaching out to higher education institutions. This endeavor is designed to establish robust partnerships with these institutions, enabling collaboration on the critical issues of NCDs and climate change. Keep up with us for more updates

# STOWELINK PARTICIPATES IN THE PRESS STATEMENT ON TOBACCO FARMING AND THE CONTROL OF TOBACCO USE FOR PUBLIC HEALTH

Stowelink, together with major tobacco control players and NCD advocates, gathered at Sarova Stanley Nairobi on August 14th for a press statement on Kenya's contribution in reducing tobacco production and promoting alternative farming for public health. The statement was necessary because of the implication by the Trade and Investment Cabinet Secretary in Kenya that a thriving tobacco business is beneficial for the economy.

The joint Statement was spearheaded by many organizations in Kenya. They included the NCD Alliance Kenya, Kenya Tobacco Control Alliance (KETCA), Consumer Information Network (CIN), International Institute For Legislative Affairs (IILA), National Taxpayers Association, Kenya Network of Cancer Organizations (KENCO) and Students Campaign Against Drugs (SCAD).





# STOWELINK IS REPRESENTED IN THE RESET ALCOHOL INITIATIVE FORUM

Stowelink was represented by Mr. Oduor Kevin at the RESET Alcohol Initiative Forum. The initiative is geared toward bringing together national governments, civil society, research organizations, and global leaders in public health and alcohol policy to develop and implement evidence-based alcohol policies from the World Health Organization's (WHO) SAFER technical package. The object of this forum was to present an assessment report on proposed amendments to the Alcohol Drink Control Act (ADCA) in Kenya, 2010, and the corresponding county legislation. The International Institute for Legislative Affairs (IILA) , with support from Movendi International and Vital Strategies, is advocating for alcohol control through taxation, and legal and policy changes.

Some of the amendments proposed in the ADCA 2010 include anchorage of alcohol taxation in the legal instruments as one of the fiscal measures to reduce consumption.
